India Creating Efficient, Trusted Global Supply Chain: PM Modi

New Delhi: Prime Minister Narendra Modi on Sunday noted the irreversible change of disruption in the global supply chain with the onset of Covid-19 pandemic and affirmed India's position in creating a trusted supply chain in the world today.

Throwing light on the transformations in life that occurred with the onset of Covid-19 pandemic. the Prime Minister while addressing the B20 Summit questioned the efficiency of the global supply chain that ceased to exist when the world required it the most. He underlined that India is the solution to the disruptions that the world is dealing with today.

PM Modi highlighted India's position in creating a trusted supply chain in the world today and emphasized the contributions of global businesses.

Speaking about the B20 theme 'R.A.I.S.E.', the Prime Minister said that even though the 'I' represents innovation, he pictures another 'I' of inclusiveness. He informed that the same vision has been applied when inviting the

PM Modi noted that the successes of the decisions taken here will have a direct impact in dealing with global economic challenges and creating sustainable growth.

Noting the role of ISRO in the successful Lunar mission, the Prime Minister also acknowledged the role of the industry in the mission as many components of Chandrayaan were provided by the private sector and MSMEs. "This is a success of both science and industry," he said.

He continued that along with India, the entire world is celebrating the achievement and this celebration is about running a responsible space programme.

The PM suggested a reconsideration of the traditional approach to business. He said that there is a need to go beyond brand and sales. He said, "As a business, we also have to focus on creating an ecosystem that will benefit us in the long term. Now, due to the policies implemented by India in the past few years, 13.5 crore people have come out of poverty in just 5 years. These people are the new consumers. This neo middle class is also giving momentum to India's growth. That is, the net beneficiary of the work done by the government for the poor is our middle class as well as our MSMEs."

Modi asked the global business to fix a day to talk about the interest of the consumers. He asked, "When we talk about consumer rights, should not we also be mindful of consumer care as it will automatically take care of consumer rights issues? We should definitely think about a system for International Consumer Care Day'," said PM Modi.

(Powell) wasn't making a pre-announcement of the decision, nor should he, but he's clearly signalling as is appropriate. The policy needs to continue to be restricted for a period of time in order for them to meet their mandate.

'G20's Mandate Can't Advance if Global South Concerns Not Met'

Jaishankar says International system remains dominated by the global north

New Delhi: The core mandate of the G20 is to promote economic growth and development, and that cannot advance if the crucial concerns of the Global South are not addressed, external affairs minister S Jaishankar said on Sunday.

"For a variety of reasons that range from scale, subsidy, technology, human resources & strategic choices, the Global South was reduced to being a consumer rather than a producer," Jaishankar said in his address at the B20 Summit organised by CII ahead of the September 9-10 G20 Summit.

"It is, however, an undeniable reality that the international system remains dominated by the Global North. This is naturally reflected in the composition of G20 as well. Perhaps this mattered less when the globalisation process appeared to offer more opportunities but as its inequities and unevenness became more apparent and then as we saw the Covid pandemic take a horrific toll across the world, the need to focus on developing countries became more compelling," the minister said.

"Their contribution very often was to provide resources for manu-

facturing elsewhere. They not only didn't reap the full benefits of economic change but often ended up saddled with unviable debts emanating from opaque initiatives."

He noted that the ongoing global

challenges, including the repercussions of the Ukraine conflict on food, energy and fertiliser security, have added to complexities.

"When India assumed the G20 presidency last December, we were acutely conscious that most of the Global South would not be at the table when we met, this mattered very much... therefore PM decided to convene the Voice of the Global South Summit in January this year and we heard about their challenges and priorities, and these have been made central to the G20 agenda."

"Today's India is the one where the world simultaneously witnesses experimentation, scaling up, deployment, innovation and breakthroughs. I stress these developments not only because they solve 1/6th of the world's problems, but because they provide replicable models for the rest of the Global South." Jaishankar said.

"We have also stepped forward as the first responder in disaster, emergency and conflict situations ranging from Fiji and Myanmar to Mozambique, Yemen and Turkiye," he added.

The B20 Summit India brings policymakers, business leaders and experts from across the world to deliberate and discuss the B20 India Communique.

Need to Keep in Mind ESG Cost Math: ITC's Sanjiv Puri

New Delhi: The cost considerations of implementing environmental, social and governance (ESG) framework for India's small enterprises need to be kept in mind so that they do not become inflationary and impact growth, Sanjiv Puri, chairman and managing director, ITC, told ET.

"We have to think of the solutions so that we are not creating a structurally inflationary environment, which will not be good for growth," Purisaid on the sidelines of the CII B20 Summit in New Delhi, pointing to the need for the development of models that are economically viable.

Puri, the head of the ESG in Business Action Council, noted technology accessibility, funding at attractive rates and sharing of cluster-based assets as solutions to control the cost of ESG compliance for MSMEs.

"If everything becomes cost plus, the environment is going to become inflationary, which will ultimately impact consumption," Puri noted, highlighting



that the finance minister, in her B20 address, also made the point of containing inflation.

Puri also highlighted that larger players also had a responsibility, and the CII-ITC Centre of Excelence for Sustainable Development was working on making a simplified ESG framework and ensuring that it percolates to the rest of the supply chain. "We have made a toolkit for MSMEs," he said.

The chairman of the Indian multinational company noted that the market needed both incentives and disincentives to implement ESG and evolve into a regulatory pathway.

"It has to be mandated with mar-

ket-based incentives and disincentives. India is also moving in that direction," Puri said, giving examples of the development of the carbon market.

The ITC chairman stressed the need for standardisation to address confusion around ESG norms and pointed out that the ESG framework needed to fit the needs of the Global South and not just be attuned to western thinking.

"The Global South adaptation is very important because two-thirds of livelihoods in the Global South are connected with nature," Puri pointed out, saying the world needed a model that "is integrative, inclusive, and graded depending on the size of company and type of geography".

Stressing the need for decarbonisation and adaption, Puri said that investment in ESG frameworks was no longer a matter of choice for the industry, especially with the number of extreme weather events increasing.

"There are some areas where pathways are unclear, where research and development has to play a role," according to Puri.

Public Digital Infra Will Improve Capital Access: Mastercard CEO

Michael Miebach lauds India's tremendous step in data exchange; UN's Songwe highlights Aadhaar model

New Delhi: India's public digital infrastructure will help provide a broad section of once-unbanked, lower-income groups access to capital, according to Mastercard CEO Michael Miebach. The data these systems generate is gender neutral and helps women entrepreneurs to borrow as well, he said at a session on Financial Inclusion for Economic Empowerment at the B20 summit in Delhi organised by the Confederation of Indian Industry (CII).

Some of Africa's digital systems are built on India's Aadhaar framework, said Vera Songwe, United Nations (UN) under-secretary general and executive secretary of the Economic Commission for Africa.

"India has one of the best digital transformation teams and we brought that team over (to) tell us what was happening. Today, countries like

Ethiopia, Botswana, Togo are using... the Aadhaar system," Songwe said.

Songwe and Miebach stres-

sed the relevance of public digital infrastructure as a means of social uplift. According to Miebach, a common thread linking small and medi-

um-sized enterprises from less developed to emerging markets is capital access. This can be addressed by technologies such as open banking, which allows data to be shared.

"India has taken a tremendous step forward with a government-led data exchange platform. There's a

lot you can do with private sector and public sector, as it happened in India," he said.

Miebach said data such as the credit score of fema-

le entrepreneurs can come in handy for disbursing loans.

In addition to easier access to loans, there is also a need to lower the cost of borrowing. According to Songwe, investments in sectors such as energy are impacted due to transition risks that drive up capital costs.

CEO, Mastercard

Abdul Matlub Ahmed, president of India-Bangladesh Chamber of Commerce, highlighted how women in Bangladesh are using the internet to earn a living. Another aspect of digitalisation is the digital identity that Aadhaar has provided to millions of Indians, according to Miebach.

"With Aadhaar, you have taken a critical step forward in the digital economy with a digital identity," he said. But the problem is that someone without an Aadhaar ID is a "digital havenot." Panelists also flagged the need for robust cybersecurity to be adopted while opting for digital transactions.

In investment pitch, PM invokes 'mutual trust', takes aim at China

New Delhi: Prime Minister Narendra Modi on Sunday invoked "mutual trust" and "democratic values" to pitch for investments in India, as he cited disruptions in the supply chain during Covid-19 to hit out at China, and sought global cooperation for ethical use of artificial intelligence, sharing of critical mineral assets and regulating cryptocurrency.

"The world has undergone significant changes both before and after Covid-19. We are witnessing irreversible changes in many aspects. Now, global supply chains cannot be seen the same way as before. It used to be said that as long as the global supply chain is efficient, there is no need to worry. However, such a supply chain can break precisely when the world needs it the most," the PM said. His remarks were seen as reflecting complaints against China for "weaponising" masks and other products needed for protection against coronavirus and profit gouging.

The PM made a vigorous pitch for India as a crucial component of the "supply chain" which is expected to curb the dependence on China. "Today, the world is grappling with this question, I assure you, my friends,



that India is the solution to this problem. India holds a crucial position in building an efficient and trusted global supply chain.

Therefore, global businesses need to step up their responsibility to make this happen, and together, we must," he said while addressing the B20 meet with industry leaders in attendance. TNN

ithout naming China, PM Modi called for a more balanced approach to doing business. "A profitable market can be sustained when there is a balance in the interests of producers and consumers. This also applies to nations. Treating other countries only as a market will never work. It will harm even the producing countries sooner or later. Making everyone equal partners in progress is the way forward," he said.

The statement, which came days after Modi's meeting with Chinese President Xi Jinping on the sidelines of the Brics summit in Johannesburg, signals India's continued discomfort with its neighbour amid heightened tensions at the borders.

With China sitting on a pile of critical minerals across the globe, Modi also cautioned that it could lead to a new model of colonialism. "If our focus is self-centred, then it will neither benefit ourselves nor the world. We are experiencing this challenge in critical

minerals, rare earth. These are available in large quantities in some places and are missing in other places. But the entire mankind needs it. Those who have it and do not see it as a global responsibility, then it will promote a new model of colonialism," he said.

Besides, he suggested an "integrated approach" towards cryptocurrency, an issue which is high on India's priority list for the G20 leaders' summit next month. "We need a global framework, keeping in mind the interests of all stakeholders," he added.

Modi also flagged concerns around artificial intelligence. "World over, there is excitement about AI, but there are also some ethical considerations. These relate to skilling and re-skilling, algorithm bias and its impact on society. We need to work together to find a solution," he said.

Pointing to changes in eating habits and health consciousness post-Covid, Modi said he had come forward with the idea of "green credits", focused on "planet positive actions", instead of carbon credits.

Global South now saddled with unviable debt: EAM dig at China

'We Cannot Be At The Mercy Any Longer Of A Few Suppliers'

New Delhi: The core mandate of the G20 is to promote economic growth and development and that cannot be advanced if the crucial concerns of the Global South are not addressed, said foreign minister S Jaishankar who is likely to travel to Cuba next month for a summit of the G77+ China, the largest intergovernmental group of developing countries.

Speaking at a business meet Sunday, which was also addressed by PM Modi, Jaishankar said in an apparent dig at China's lending practices that the Global South, which was largely reduced to being a consumer rather than a producer, was now even saddled with unviable debt that had resulted from "opaque initiatives".

"We cannot be at the mercy any longer of a few suppliers whose viability could come in-

to question by unanticipated shocks. This was starkly apparent when it came to health during the Covid pandemic, but it pretty much applies to everything else as well," he said, adding the effort now is for a more diversified re-globalisation that would have multiple centres of production, and not just consumption.

The minister's likely visit to Cuba for a summit of the

heads of state and government, barely a week after the conclusion of the G20 leaders' summit, will be significant as both India and China stake a claim to the leadership of the developing world and India looks to consolidate the gains from its focus on the Global South in G20. Founded in 1964, G77 + China counts 134 countries, including India, as members and is an important platform for addressing issues related to sustainable development, inequality and poverty eradication.

China says it's not a member but works very closely with the group, and hence the name G77 + China. From Cuba, Jaishankar will also travel to New York where he will address the 78th session of the UN general assembly.

Jaishankar's will also be a rare visit by an Indian foreign minister to a country that remains crippled by US economic sanctions and has sought to build ties with China, with the US accusing Beijing of using Cuba as a spy base.

Bilateral exchanges have continued though with former President Ram Nath Kovind visiting Cuba in 2018 and union minister Meenakshi Lekhi earlier this year, during which Cuban President Miguel Diaz-Canel thanked her for India's support against "the blockade" and for shipment of rice.

five years. Many multilateral agencies and global groups are coming forward and showing interest, and the next few years will see proliferation and prevalence of digital infrastructure at population-scale around the world-Going forward, the approach of DPI can also help in climate adaptation and mitigation, he said.

"One of the things which will happen in climate adaptation is you want to give anticipatory financing for building more resilient homes, in anticipation of higher seal levels etc. And you can do that using DPI or using ONDC,"he said. AGENCIES

NEW DELHI: External affairs minister S Jaishankar on Sunday made a strong pitch for a "more diversified and more democratic" re-globalisation, saying the Global South can no longer be at the mercy of a few suppliers. Addressing the B20 Summit organised by CII in Delhi, he said the Global South was largely reduced to being a consumer rather than being a producer and could not reap the full benefits of economic change.

"They (Global South) not only did not reap the full benefits of economic change, but often ended up saddled with unviable debts emanating from opaque initiatives. This was a gradually unfolding crisis in the making, but one that was accelerated rapidly by the multiple shocks of debt, Covid and conflict," Jaishankar said addressing a session on 'Role of Global South in Emerging World 2.0'.

"As a result, the endeavour now is to seek re-globalisation that is more diversified, more democratic, where there would be multiple centres of production, not just of consumption. That is where business can make a crucial difference," he added.

He said the core mandate of G20 was to promote economic growth and development and it cannot advance if the crucial concerns of the Global South in areas such as debt and finance, sustainable development, climate action, food security and women-led development were not addressed.

"We cannot be at the mercy any longer of a few suppliers whose viability could come into question by unanticipated shocks. This was starkly apparent when it came to health during the Covid pandemic, but it pretty much applies to everything else as well," he said. He said the compulsion to create more resilient and reliable supply chains was a really pressing one

Create framework for ethical use of AI: PM at B20 summit

Days after the BRICS Summit, Modi also reiterated the importance of India's role in setting up resilient and inclusive global supply chains.

Noting the excitement around AI, Modi pointed out some ethical considerations. "The world has to come together to solve the challenges of skilling and reskilling, and algorithmic bias and its impact on society. Global business communities and governments have to ensure the expansion of ethical Alacross different sectors... the disruption is beyond our thinking, and we have to create a global framework." he said.

He cited the examples of the aviation and financial sectors which have seen global coordination. Positioning India as a crucial element in the global supply chains which were disrupted during the pandemic, he said: "We have seen some irreversible changes since Covid-19, global supply chains cannot be seen like earlier. Can a supply chain be called efficient if it breaks when the world needs it the most...The

solution to that problem is India. Efficient and trusted supply chains in India have an important place."

Stressing on mutual trust, he pitched India as a key player internationally. "Mutual trustneeds the most investment... and the country that can function with humility and sensitivity is India," he said. "Your partnership with India is very important... if your friendship is strong with India, it will result in prosperity for both," he added.

Cautioning against a "selfcentric" approach, Modi said that if businesses and governments don't shoulder global responsibility, it could result in a "new colonial model"

"If our focus is self-centric, we won't be able to help ourselves or the world... We are seeing that in the case of rare earth metals - some regions have them in abundance, while some don't, even as the whole world needs them. This could become a new colonial model." he said.

"A profitable market can be sustained when there's a balance

in the interest between producers and consumers. Consumers can be both individuals and countries. Treating countries just as a market will not work. Making everyone equal partners in progress is the way forward," he said

Modi also urged business leadersto look beyond consumer rights, and focus on consumer care. "Can we talk about consumercare? It will send a positive signal and will resolve consumer rights issues. We need to boost trust between businesses and consumers," he said, and suggested that a day should be observed as "international consumer care day".

The Prime Minister also highlighted the contribution of various Indian MSMEs and private companies in the success of the country's lunar mission, Chandrayaan-3. "Many components that were needed to make the mission a success were developed and provided by private companies and MSMEs in time... it is the success of science and the industry," he said.

"They (Global South) not only did not reap the full benefits of economic change, but often ended up saddled with unviable debts emanating from opaque initiatives. This was a gradually unfolding crisis in the making, but one that was accelerated rapidly by the multiple shocks of debt, Covid and conflict," laishankar said.

"As a result, the endeavour now is to seek re-globalisation that is more diversified, more democratic, where there would be multiple centres of production, not just of consumption. That is where business can make a crucial difference," he said addressing a session on 'Role of Global South in Emerging World 2.0'.

Jaishankar said the core mandate of G20 was to promote economic growth and development and it cannot advance if the cru-

cial concerns of the Global South in areas such as debt and finance, sustainable development, climate action, food security and women-led development were not addressed. "We cannot be at the mercy any longer of a few suppliers whose viability could come into question by unanticipated shocks. This was starkly apparent when it came to health during the Covid pandemic, but it pretty much applies to everything else as well," he said.

Jaishankar said the compulsion to create more resilient and reliable supply chains was a really pressing one. "Its counterpart in the digital domain is driven more by anxieties about trust and transparency. The volatility of the last few years have brought home to us the importance of strategic autonomy," he said.

He said a more just, equitable and participative global order will only happen when there was commensurate investment, trade and technology decisions directed at the Global South.

Seeing green shoots of pickup on volumes as inflation moderates: ITC CMD Puri

NEW DELHI, AUGUST 27

AS INFLATION is moderating, diversified group ITC is seeing green shoots of volume growth and expects the momentum to continue sequentially, its Chairman and Managing Director Sanjiv Puri said on Sunday.

This will certainly lead to improvement in volume, but it will not happen overnight, said Puri here on the sidelines of the B20 Summit organised by the CII.

Over the ITC's plan for the demerger of its hotel business, Puri said it is going to benefit the existing shareholders by incorporating a wholly-owned new subsidiary ITC Hotels Ltd.

"It will be a pure-play, focused on hospitality, which can leverage the institutional

strengths of ITC. And ITC in turn will be able to leverage the synergy on its hospitality business, or its FMCG businesses," Puri told PTI.

It is a "very robust" model, which will help the business to make the hotel business accelerate progress, whilst retaining synergies and it will improve the financial metrics of ITC, he added.

Over inflation, Puri said this is mainly on account of two factors - the bigger one is more of the external factors in the geopolitical environment and the second is on account of the issues of climate change.

"However, now, India is much better placed in the rest of the world and I would like to compliment the government for stewarding management of inflation and being extremely proactive in taking the right steps to control that," he said.

In the recently concluded June quarter, ITC and several other FMCG makers reported volume gains and improvement in margins. ITC has 25 brands including Aashirvaad, Bingo, Sunfeast, YiPPee, Fiama, Vivel, Savlon etc.

When asked about the re-

vival of consumer sentiments and volume growth, especially in the rural market, Puri said, "So we are already seeing green shoots of pickup on volumes as inflation is moderating. I think as inflation moderates, we are also seeing the prices in the market growing or climate is improving."

He expressed concerns that the operating environment continues to remain volatile on the weather front.

"Right now, the El Nino is the monitorable. The rains in August have not been very encouraging. That's the facet we need to be watchful about. But overall, I think we have been able to manage it quite well," said Puri.

The Kolkata-headquartered firm reported a 16.08 per cent rise in consolidated net profit to Rs 5,180.12 crore in the June quarter.

BP CEO calls for investments in oil & gas projects, orderly energy transition

NEW DELHI, AUGUST 26

UNITED KINGDOM-based energy giant BP's Chief Executive Officer Bernard Looney on Saturday called for an energy transition roadmap that is "rapid yet orderly", while underscoring the importance of maintaining requisite investments in the existing energy systems dominated by the oil and gas sector. Looney's views were consistent with those of energy hungry emerging economies like India that are expediting transition to clean energy but are still heavily dependent on fossil fuels.

Speaking at the B20 Summit organised by the Confederation of Indian Industry, Looney said that oil and gas will continue to be key sources of energy for "many decades to come" and it will be critical to maintain a global demand-supply balance, for which, enough investments in the sector will be needed in order to avoid major price shocks. The oil and gas sector accounts for around 55 per cent of the global energy consumption pie.

"We must invest in today's energy system, while at the same time investing in (energy) transition. If we don't do that, we see examples of what can happen. Last year, through the (Ukraine) war, we lost 3 percent of the world's gas supplies. The result of that was that gas prices went up seven times...That obviously impacts people...It also means that governments turnto other forms of energy that is cheaper, like coal," Looney said.

"So what the world needs

both in the Global North and in the Global South, is we need an 'and' and not 'or' strategy. We need to do both. We need to invest in today's system responsibly and at the same time, we must invest in accelerating the transition." he added.

A number of European countries, which had earlier been at the forefront of energy transition and clean energy investments, increased use of coal for producing power after gas prices shot up in the wake of Russia's invasion of Ukraine.

On its part, India has been advocating for necessary investments in oil and gas projects to ensure that enough production is available to meet global demand in the years to come, while also making efforts to accelerate transition to green energy.

As the third-largest consumer of crude oil that depends on imports to meet over 85 per cent of its requirement of the commodity, India is extremely sensitive to volatility in the global oil market.

He was addressing the B20 Summit India 2023, which is the official G20 dialogue forum with the global business community, in New Delhi.

While addressing the meet, Modi said the world had irreversibly changed between the pre-pandemic and post-pandemic times, and India had become the face of digital revolution in the era of Industry 4.0. "Earlier, it was said that as long as the global supply chain is efficient, there is nothing to worry about. But can such a supply chain be called efficient when it breaks down, and that too when the world needed it the most? Therefore, today when the world is grappling with this question, I assure you that the solution to this problem is India. India has an important place in building an efficient and trusted global supply chain," Modi added.

Modi said treating other countries only as a market would not work but harm even the producing countries, sooner or later. "A profitable market can be sustained when there is a balance in the interests of producers and consumers. This also applies to nations. Treating other countries only as a market will never work. Making everyone equal partners in progress is the way forward," he added.

Highlighting the success of his government



in lifting 135 million people out of multi-dimensional poverty in just five years, the Prime Minister said these people constituted the neomiddle class and were the biggest consumers because they came with new aspirations. "The neo-middle class is also giving momentum to India's growth. As the purchasing power of the middle-class increases, it has a direct impact on the businesses. As a business, we also have to focus on creating an ecosystem that continues to give benefits in the long term," he added.

While speaking about critical minerals, he said there was a risk of a 'new model of colonialism' if nations with critical minerals did not regard custodianship as a "global responsibility", as firms race to secure resources central to energy transition goals.

The Prime Minister stressed the need for a more integrated approach on cryptocurrencies and artificial intelligence (AI), and suggested creating global frameworks where issues of all stakeholders could be addressed.

Problems in Global South will spill over: Jaishankar

New Delhi, 27 August

Developed nations must remember that globalisation cuts both ways, and unaddressed stress in the Global South will have far-reaching consequences worldwide, External Affairs Minister S Jaishankar said on Sunday.

Speaking at the B20 summit, Jaishankar asked business leaders to consider the impact of slow-down in nutrition, health, employment and security because of breakdown in societies of the Global South. He said this slowdown would spill over to the rest of the world.

"The current focus on the Global South emanates from the conviction that these countries truly deserve special care. But equally also, these are societies that are under exceptional stress, which if left unaddressed, would become a serious drag on the world economy. Remember, globalisation cuts both ways," he said at the summit organised by the Confederation of Indian Industry (CII).

Global South is used to describe countries characterised by low income, dense population and poor infrastructure. These nations often face political or cultural marginalisation.

Jaishankar said the international system remained dominated by the Global North, which has only one-fourth of the global population.

"Perhaps this mattered less when the globalisation process appeared to offer more opportunities. But as inequities and unevenness became more apparent, the need to focus on developing countries became more compelling," he said.

Further, the Ukraine conflict has raised concerns on global food, energy and fertiliser security. With an audience comprising prominent figures from across sectors and geographies, the session highlighted the significance of the Global South in the contemporary world order.

When India took over the presidency, it recognised that most nations in the Global South were not going to be on the agenda. So, it took the initiative of including the African Union in the G20, the minister said.

Strategic autonomy

India seeks a 'reglobalisation', which is more diversified and democratic, with multiple centres of production, rather than only consumption, he said.

Delhi is, therefore, focused on creating resilient and reliable supply chains. On the other hand, the digital domain is driven more by anxieties in trust and transparencies, he said.

TASK FORCE

About 170 people across the world participated in the work of this task force, whose main purpose was to encourage collaboration in R&D and innovation to build technology for sus-

"The whole idea of a platform on R&D and technology is to see if we (India) can build one such collaborative platform and gift it to G20 countries. This can be a collaborative platform where people can put their ideas and challenges and other people can come and say this is how we can together solve it. People wanting funding also can put their requests for funding," Gopalakrishnan businessline.

Gopalakrishnan also said that preliminary discussions have been held with Brazil and "together we want to build this and there will be implementation when the Secretariat shifts to Brazil".

This task force has identi-

fied four areas where its recommendations are centred—Digital Tech; Deep and Emerging Tech; Green Tech/Circular Economy and Foundational domains of influence.

If those having it do not see it as their global responsibility, it will strengthen a new model of colonialism. I am giving a serious warning," he told the global business community.

The PM's remarks come as a global hunt for critical and rare earth minerals gathers further momentum because of their increasing use in areas such as renewable energy, energy storage, telecommunications, defence and healthcare.

In June this year, India became a member of the coveted critical minerals club, the Mineral Security Partnership (MSP), an announcement that was part of a joint statement by Modi and president Joe Biden during Modi's US visit in June.

MSP is a strategic grouping of 13 coun-

Green energy transition not easy: Tata Steel CEO



PRESS TRUST OF INDIA New Delhi, August 26

THERE IS NO "silver bullet" for green transition in hard-to-abate sectors, including steel, Tata Steel global CEO & MD TV Narendran said on Saturday, noting it's a complex challenge and needs government support.

The statement comes amid growing concerns across economies over emissions, and need to increase usage of green energy. Steel is the most commonly used metal in the world. Even for

the transition, steel will be needed, whether to hold solar panels up, windmills, storage and pipelines, he said, addressing a session at B20 Summit India 2023.

"You need to find a solu-

tion and there is no silver bullet for that... India is alone going to add 100-150 million tonne steel capacity every decade...," he said.

Supply chain in steel sector has been built over 100 years, so transitioning from coal to gas to hydrogen even from supply chain point is a very complex challenge, Narendran, who is also the chairman of manufacturing council of industry body CII, said. "This journey is going to be significant and we should not underestimate that the industry can support part of the cost... cost of transition so needs government support. You need customers to be willing to pay more for green products; it's a long journey and I think journey has started in Europe and the US," he said. In India, very ambitious renewable energy targets have been set and a lot needs to be done. The transition can happen only if there is a policy framework to support it and carbon markets which are there in Europe.

Focusing on inclusive growth in India, Prime Minister Narendra Modi on Sunday called for a global framework on cryptocurrencies and an ethical usage of artificial intelligence Addressing the B-20 Summit India 2023, Mr Modi highlighted a slew of issues, including the importance of consumercentric growth, the digital revolution, green credit, the global supply chain, Isro's Chandrayan-3 success, and the poor and middle class, among others.


Questioning the efficiency of the global supply chain that ceased to exist when the world required it the most, Modi underlined that India is the solution to the disruptions that the world is dealing with today.

Digital Public Infra can help in climate mitigation: Nilekani

NEW DELHI: The approach of Digital Public Infrastructure, which has gained global prominence, can also help in the area of climate adaptation and mitigation going forward, Chairman and Co-Founder of Infosys and the founding Chairman of UIDAI, Nandan Nilekani said on Sunday.

Nilekani, speaking at the B20 Summit India organised by CII, further said India has found a "balance" between responsible regulation and innovation due to its participatory model, as he showcased the country's success story on digital public infrastructure (DPI), which has accelerated inclusion in the country.

India's DPI is gaining global recognition, Nilekani said, noting there is a major move afoot to take this model to 50 countries in five years.

Many multilateral agencies and global groups are coming forward and showing interest, and the next fe years will see proliferation and prevalence of digital infrastructure at population-scale around the world.

Going forward, the approach of digital public infrastructure can also help in climate adaptation and mitigation, Nilekani said.

"For example, one of the things which will happen in climate adaptation is you want to give anticipatory financing for building more resilient homes, in anticipation of higher sea levels etc. And you can do that using DPI or using ONDC (Open Network for Digital Commerce), another great innovation to create an open network for commerce, we can create a circular economy where things get recycled,"



he said.

Hence, not only has DPI has helped so far, it will also be useful in the future.

The digital public infrastructure issues a challenge for societies, he said, adding that other countries today are fighting the question of how to balance regulation and innovation, something that India has successfully manoeuvred.

While the US, a hotbed for innovation, is now looking at approaching regulation, Europe has plenty of regulations, but not enough innovators.

"In India, we have found the balance between regulation and innovation because of the participatory model of coordinated governance from the central government, from the regulators like the Reserve Bank, technology companies and the private sector, everybody has come together to create an architecture which finds the balance between innovation and regulation," he said.

Such a model ensures that there is innovation but within the framework and guardrails of responsible regulation.

India has transformed in many ways, and this digital transformation is at the heart of economic growth.


"India is going from an offline, informal, low produc-

tivity, multiple set of micro economies to a single online, formal, high productivity mega-economy. And this is the trend of the next 20 years and you get to see all this happening every year, year by year," he said.

The transformation, he observed, has been enabled by a new approach to solving society's issues through the digital public infrastructure.

Digital public infrastructure has extended the ability of the country to use digital technology at population scale to transform society, and involves a number of building blocks.

"Each block does one thing well, but all the blocks talk to each other, they interoperate. And when these blocks come together, they create all kinds of solutions at population scale," he said.

Digital Public Infrastructure can help in climate adaptation, mitigation: Nilekani

PTI NEW DELHI

The approach of Digital Public Infrastructure, which has gained global prominence, can also help in the area of climate adaptation and mitigation going forward, Chairman and Co-Founder of Infosys and the founding Chairman of UIDAI, Nandan Nilekani said on Sunday.

Nilekani, speaking at the B20 Summit India organised by CII, further said India has found a "balance" between responsible regulation and innovation due to its participatory model, as he show-cased the country's success story on digital public infrastructure (DPI), which has accelerated inclusion in the country.

India's DPI is gaining global recognition, Nilekani said, noting there is a major



move afoot to take this model to 50 countries in five years.

Many multilateral agencies and global groups are coming forward and showing interest, and the next fe years will see proliferation and prevalence of digital infrastructure at population-scale around the world.

Going forward, the approach of digital public infrastructure can also help in climate adaptation and mitigation, Nilekani said.

"For example, one of the things which will happen in climate adaptation is you want to give anticipatory financing for building more resilient homes, in anticipation of higher sea levels etc. And you can do that using DPI or using ONDC (Open Network for Digital Commerce), another great innovation to create an open network for commerce, we can create a circular economy where things get recycled," he said.

Hence, not only has DPI has helped so far, it will also be useful in the future.

The digital public infrastructure issues a challenge for societies, he said, adding that other countries today are fighting the question of how to balance regulation and innovation, something that India has successfully manoeuvred.

While the US, a hotbed for innovation, is now looking at approaching regulation, Europe has plenty of regulations, but not enough innovators.

steel capacity every decade for the next few decades you will have these hard-to-abate sectors growing. cement production is twice the amount of steel production globally...you need to find solutions which are technical, which don't get solved by just finding another energy source," he said.

Supply chain in steel sector has been built over 100 years,

so transitioning from coal to gas to hydrogen even from supply chain point is a very complex challenge, Narendran, who is also the chairman of Manufacturing Council of industry body CII

India is the future, British energy major BP chief executive Bernard Looney said on Saturday as he lauded the country for becoming the first to land a spacecraft near the moon's south pole.

Speaking with reporters on the sidelines of B20 Summit India organised by CII, Looney said India is "taking incredible steps and doing things in a very innovative and creative way".

"We watched it back in London. Everyone around the world, I think, is excited about the country," he said. "India is the future."

BP has invested billions of dollars in an oil and gas field in the Bay of Bengal and is fast expanding a fuel retailing network that also comprises electric vehicle (EV) charging stations.

Both ventures are in alliance with Reliance Industries Ltd.

India is the world's thirdlargest energy consumer and the fastest-growing major econ-



omy in the world. While other competing economies like China slow down, India continues to grow and is eyed by investors across sectors.

"India is hugely exciting for us," he said.

The company in partnership with Mukesh Ambani's Reliance Industries Ltd, is now producing a third of India's gas production after a third set of discoveries in the KG-D6 block was brought to production.

"We are now producing approximately one billion cubic feet (BCF) a day of natural gas, that is approximately one-third of India's domestic gas production today," he said.

Besides interest in the field, BP also has a gas retailing venture and a network of 1,625 petrol pumps in the country. It also has outlets to charge EVs.

"So if we can get the twowheelers, three-wheelers, and overtime passenger vehicles converted to electric,

I think that's going to be hugely important," he said adding the joint venture is also investing in CNG and firms in EV charging and battery business.

विदेश मंत्री एस जयशंकर ने रविवार को कहा कि विकसित देशों को ध्यान रखने की जरूरत है कि वैश्वीकरण दोधारी तलवार है और अगर विकासशील देशों की समस्याओं का समाधान नहीं किया गया तो इसका वैश्विक असर होगा।

भारतीय उद्योग परिसंघ (सीआईआई) की ओर से आयोजित बी-20 सम्मेलन को संबोधित करते हुए जयशंकर ने भारत और जी-20 देशों के कारोबारी दिग्गजों से कहा कि पोषण, स्वास्थ्य, रोजगार और सुरक्षा के असर पर विचार किया जाना चाहिए, जिसकी वजह से विकासशील देशों में समाज टूट रहा है और इसका असर शेष दुनिया पर भी पड़ेगा।

उन्होंने कहा, 'विकासशील देशों पर मौजूदा ध्यान इस विश्वास से जाता है कि ये ऐसे देश हैं, जिन पर विशेष ध्यान दिए जाने की जरूरत है। लेकिन साथ ही ये ऐसा समाज है, जहां बहुत ज्यादा तनाव है। अगर इस पर ध्यान नहीं दिया गया तो वैश्विक अर्थव्यवस्था के लिए बडी समस्या पैदा हो जाएगी।

ऐतिहासिक वजहों से वैश्विक दक्षिण खपत के केंद्र में बना हुआ है और बजट का बड़ा हिस्सा उसके पास है और वह आर्थिक विकास में सार्थक निवेश के अवसर छीन रहा है। कारोबार संबंधी विवाद, ज्यादा ब्याज दरें और जयवायु संबंधी बढ़ती गतिविधियों ने अतिरिक्त दबाव डाला है।

रणनीतिक स्वायत्तता

भारत ने नए सिरे से वैश्वीकरण की मांग की है, जो ज्यादा विविधता वाला और लोकतांत्रिक हो और उत्पादन के और ज्यादा केंद्र हों। इसलिए भारत ज्यादा लचीले व विश्वसनीय आपूर्ति श्रृंखला पर ध्यान केंद्रित कर रहा है, जो बहुत जरूरी है। उन्होंने कहा कि डिजिटल डोमेन में विश्वास और पारदर्शिता को लेकर चिंता बढ़ी है।

जयशंकर ने कहा कि कोविड महामारी और यूक्रेन में युद्ध के कारण वैश्विक आर्थिक व्यवस्था को बार बार झटका लगा है। इससे देशों के बीच कई विश्वसननीय मूल्य श्रृंखला बनाने की जरूरत को बल मिला है।
